COMPETITION REGULATIONS

- I. The competition is open to pianists of all nationalities.
- II. The participants will be divided into 5 age categories:
 - a) born after the 1st of January, 2003 – program length: max. 6 minutes
 - b) born after the 1st of January, 2001 – program length: max. 10 minutes
 - c) born after the 1st of January, 1999 – program length: max. 15 minutes
 - d) born after the 1st of January, 1997 – program length: max. 20 minutes
 - e) born after the 1st of January, 1994 – program length: max. 25 minutes
- III. The selection of the program is completely free. The program’s quality of the structure will be taken into consideration by the jury.
- IV. The admission fee is 45€ for category “A”, 50€ for categories “B” and “C” and 55€ for categories “D” and “E”.
- V. The application deadline is **April 18th, 2014**. Please send all the required documents along with the application form to one of the following addresses

- VII. Incomplete applications will be rejected.
- VIII. The admission fee is not refundable.
- IX. The admitted participants will be notified about the order of performance by the **22nd of April, 2014**. The list and order of performance will also be available on our website (www.ars-haliaeti.si).
- X. The participants will have to present a valid document at the competition’s reception prior to their performance.
- XI. The jury’s decisions are final.
- XII. In case of misinterpretation of these regulations, it is the role of the artistic director to solve any inconveniencies regarding this matter. The Slovenian version of the regulations will be used as a reference.
- XIII. The artistic director reserves the right to change the number and/or replace any number of jurors at any given time.
- XIV. All performances are public. The participants must perform the program from memory.
- XV. The jury may interrupt the performance, should the time limit be exceeded.
- XVI. The results will be announced after the last performance of each category.
- XVII. The jury can award one prize to two participants. In this case the prizes are equivalent.
- XVIII. The jury reserves the right not to award prizes but only in the case of unanimity.
- XIX. The participants must list the works they are going to perform on the application form. The program can be changed at any time up until 1 hour before the performance. In this case, the competition’s personnel has to be notified.
- XX. In the case of audio/video recording and/or broadcast, the participants have to waive all the rights in regards to the recordings. The recordings will remain property of the competition’s organizer.
- XXI. With the participation it is intended that the participant understands and accepts all terms stated in these regulations.
